## GENERAL CONDITIONS

1. Mobile homes and rental tents are available for a minimum of 1 week in the high season, with arrival on Saturday between 4.00 p.m. and 8.00 p.m. and departure on Saturday between 8.00 a.m. and 10.00 a.m. For pitches: arrive between 2.00 p.m. and 8.00 p.m. and depart between 8.00 a.m. and 12.00 a.m.. Arrival and leaving times can be changed only upon agreement with management.
2. The payment of a reservation deposit of 25% of the total cost is required.
3. An inventory is done at the beginning and end of each letting. Rentals must be left perfectly clean. Smoking is prohibited inside mobile homes and rental tents.
4. **A security deposit of 200€ is payable on arrival to set against any damage that may be caused by you during your visit.** You will also be contractually responsible for any additional costs that may arise in excess of this deposit. This deposit is payable by (French) cheque or in cash.
5. **A second deposit of 100€ is payable on arrival to guarantee perfect cleaning at the time of departure.** In the case of insufficient cleaning, part or all of this deposit will be held to cover our costs. Please check the cleaning conditions posted in each rental to make sure you clean to the standard that ensures the return of your deposit. This deposit is payable by (French) cheque or cash.
6. Reservations are subject to our confirmed receipt of your booking deposit.
7. If, in the absence of any written confirmation of any change to your arrival date, you do not arrive on the booked date, after 24 hours your rental or pitch will be made available for relet. You will still be liable for payment in full of the amount detailed in your contract.
8. Cancellation Policy: All cancellations must be made in writing. Cancellations by telephone only are not accepted. In the event of formal cancellation on your part, the following amounts are due:
  - Cancellation more than 30 days before arrival date: booking- and administration fees & deposit.
  - Cancellation 30 days or less before arrival date, or failure to show: total cost of booked stay.

9. Payment of the balance of your booking is due in full

- For rental accommodation: the holiday has to be settled 20 days before arrival date. If the payment has not been settled, the lodging will be considered as cancelled and the paid deposit will be kept by the camping. If you reserve within 20 days before arrival, the total amount of the holiday has to be paid.
- For a pitch on the campsite: on the day of arrival.

No deductions are made for late arrival or early departure.

10. Please note: If you want to change the dates of your stay, we can not guarantee availability of the same pitch.

11. A maximum 6 persons per pitch is allowed.

12. Every camper is required to respect and keep to the camping regulations, as posted on site.

13. **A tourist fee of 0,41€/day per person over 18 years of age is not included.**
